TERMS AND CONDITIONS

Get \$150 off your 2017 Highlanders Season Membership

Application

These Terms and Conditions apply in addition to the Pulse Energy Residential Agreement which may be amended from time to time. If there is any conflict between these Terms and Conditions and the Pulse Energy Residential Agreement, these Terms and Conditions shall prevail.

The Offer

- This offer is valid from Monday 8 August 2016 to 24 February 2017.
- Highlanders Membership means an Adult 2017 Season Ticket Membership Product purchased from The Highlanders Rugby Club Limited Partnership either online through their ticket supplier – TicketDirect, or in person at the Highlanders offices, or over the phone with the Highlanders staff.
- Offer is for one \$150.00 NZD rebate off a single or multiple transaction for 2017 Highlanders Season Membership, when the ‘Highlanders Member’ completes the switch and becomes a customer of Pulse Energy.
- The Highlanders Member must complete their 2017 Highlanders Membership transaction, and will then be contacted electronically by The Highlanders with instructions on how to switch their electricity to Pulse Energy and access the \$150.00 NZD rebate
- By becoming a Highlanders 2017 Member, the member allows Pulse Energy the right to contact them regarding Electricity services and promotional offers, unless the member opted out of this during their Membership Transaction process
- The ‘Highlanders Member’ must switch their electricity to Pulse Energy to be eligible for the rebate.
- Only one rebate of \$150.00 NZD per unique household address that becomes a Pulse Energy Customer, per ‘Highlander Member’. That means if you purchase only one or more than one membership from one residential address, you only receive one \$150.00 NZD rebate.
- Rebate only applies to the property which the ‘Highlanders Member’ has instructed as their registered address.
- However, the rebate may not be payable until the member has completed their 2017 Season Membership payments to Debit Success and have no outstanding financial obligations to any involved parties.
- \$150.00 NZD rebate will be refunded by The Highlanders Rugby Club Limited Partnership, within 6-8 weeks of becoming a customer of Pulse Energy and purchasing the 2017 Highlanders Season Membership.
- The Highlanders Rugby Club Limited Partnership will liaise directly by email and phone with the member and electronically transfer the \$150.00 NZD rebate to that member’s nominated NZ Bank Account. The Highlanders take no responsibility for providing eligible rebates if the member cannot be reached by the member-provided phone number or email address

- If you leave Pulse Energy within 12 months of switching, will be required to pay \$150. This will be added to your final account.
- The \$150 rebate applies to Highlanders Season Membership Products of Highlanders Platinum (Adult), Highlanders Gold (Adult), and Highlanders Take a Kid to the Highlanders Family pass (where the purchase is for a minimum of 1 adult and 1 child).
- The offer does not apply to single purchases of child Season Membership Products, or to single “Additional Adult” or to single “Additional Child” add-ons for Take a Kid to the Highlanders
- This offer is only available to new customers (ICP) of Pulse Energy on our Freedom Plan and is not available to current customers of Pulse Energy, Just Energy or Grey Power Electricity.
- The promotional code ‘HIGHLANDERS’ must be entered when completing the online sign up at www.pulseenergy.co.nz/join
- This offer cannot be used in conjunction with any other offers.
