PROMOTION – GENERAL RULES

GENERAL

1. The Specific Rules for a Promotion, along with these General Rules, form the terms and conditions for the Promotion (the “**Rules**”).
2. The Promotion is open to New Zealand residents only. In addition to any restrictions noted in the Specific Rules, the following individuals may not enter this Promotion:
 - (a) employees of The Highlanders, participating sponsors, promoters and/or associated advertising agencies (and their family members);
3. The Highlanders’ decision is final in relation to the selection of prize winner(s), any dispute regarding the Rules, and/or the conduct or the results of a Promotion.
4. The Highlanders reserves the right to cancel, terminate, modify or suspend the Promotion and/or vary the Rules at any time without prior notice.
5. The Highlanders may refuse or disqualify any entry (including winning entries) if The Highlanders decides in its sole discretion that the entrant has not complied with these Rules, or if he or she has acted in a way which The Highlanders reasonably considers to be inappropriate, unlawful, offensive or otherwise not in the spirit of the Promotion. If the winning entry is disqualified, The Highlanders reserves the right to award the prize to another entrant without notice to the disqualified entrant(s).
6. Where a winner is selected by a voting mechanism: The Highlanders’ decision on voting arrangements and validity of votes will be final. The Highlanders reserves the right to discount votes if The Highlanders suspects bulk voting is taking, or has taken place, to inappropriately influence or manipulate the voting procedures. The Highlanders reserves the right to disqualify anyone who is suspected of engaging in, or benefitting from, irregular or fraudulent voting.
7. The Promotion is governed by New Zealand law.

PRIZES

8. The Highlanders reserves the right to substitute the prize(s) for a prize of equivalent or greater monetary value.
